## **SPECTS 2010 Camera-Ready Submission Instructions**

The SPECTS 2010 papers will be electronically published by **IEEE Xplore**. This means that accepted papers must exactly fulfil the IEEE requirements regarding the final submitted version. The maximum length is 8 pages for regular papers, and 6 pages for WiP papers. Extra pages will be charged extra fees.

Please follow strictly the following steps:

- 1. Modify your paper according the reviewers comments and generate the Camera-Ready version of your paper using one of these NEW templates
  - [http://www.ieee.org/web/publications/pubservices/confpub/AuthorTools/conferenceTemplates.html] (please use A4 paper size templates, no page numbers, no headers, no footers)
- 2. Generate a PDF version of your Camera-Ready paper form step 1 and validate it using the PDF eXpress tool. (You can also use PDF eXpress tool to generate the PDF version). Please go to the IEEE PDF eXpress website [http://www.pdf-express.org/]:
  - First-time users:
    - Click "New Users Click Here".
    - 2. Enter spects10x for the Conference ID, your email address, and choose a new password. Continue to enter information as prompted.
    - 3. Check that the contact information is still valid, and click "Submit".
  - Previous users, but using it the first time for a new conference:
    - 1. Enter spects10x for the Conference ID, your email address, and enter the password you used for your old account.
    - 2. When you click "Login", you'll receive an error saying you need to set up an account. Simply click "Continue". By entering your previously used email address and password combination, you will enable your old account for access to this new conference.
    - 3. You will receive online and email confirmation of successful account setup.
    - 4. You will receive online and email confirmation of successful account setup.
  - o Returning users:
    - 1. Enter spects10x for the Conference ID, email address and password.
- 3. For each conference paper, click "Create New Title".
- 4. Enter identifying text for the paper (title is recommended but not required).
- 5. Click "Submit PDF for Checking" or "Submit Source Files for Conversion"
- 6. Indicate platform, source file type (if applicable), click Browse and navigate to file, and click "Upload File". You will receive online and email confirmation of successful upload.
- 7. You will receive an email with your Checked PDF or IEEE PDF eXpress-converted PDF attached. If you submitted a PDF for Checking, the email will show if your file passed or failed.
- 8. If the PDF submitted fails the PDF check:
  - Submit your source file for conversion by clicking Try again, then Submit Source Files for conversion,
     or
  - Read the PDF Check report, then click "The PDF Check Report" in the sidebar to get information on possible solutions or,
  - "Request Technical Help" through your account.
- 9. If you are not satisfied with the IEEE PDF eXpress-converted PDF:
  - o Resubmit your source file with corrections (Try again, then Submit Source Files for Conversion), or,
  - o Submit a PDF by clicking **Try again**, then **Submit PDF for Checking**, or,
  - "Request a Manual Conversion" through your account.
- 10. If the PDF submitted passed the PDF Check, or you are satisfied with your IEEE PDF eXpress-converted PDF:
  - Submit the Camera-Ready version (PDF generated in step 2) before MAY 28, 2010. To upload your final
    manuscript, please go back to the submission site: <a href="http://www.softconf.com/scs/SPECTS10/">http://www.softconf.com/scs/SPECTS10/</a> and, on the
    left-hand side of the page, enter the passcode associated with your submission (received by each author
    by e-mail).
  - NOTE that an additional condition for the inclusion of a paper in the conference is the registration of at least one of the authors (information about registration available soon) and the submission of the copyright form [http://atc.udg.edu/SPECTS2010/SPECTS Copyright form.pdf].

**ATTENTION:** Papers not using the right template or that do not pass the IEEE PDF eXpress checklist will be **excluded** from the conference and the proceedings.
